WHAT DOES **UFCW UNION LOCAL 880 CREDIT UNION** DO WITH YOUR PERSONAL INFORMATION?

WHY?

Financial companies choose how they share your personal information. Federal law gives members the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

WHAT?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number
- Account balance and payment history
- Credit history and credit score

When you are no longer our member, we continue to share your information as described in this notice.

HOW?

All financial companies need to share members' personal information to run their everyday business. In the section below; we list the reasons financial companies can share their member's personal information; the reasons UFCW Union Local 880 Credit Union chooses to share; and whether you can limit this sharing.

For our everyday business purposes - such as to process your transactions, maintain your account(s), respond to court orders, and legal investigations, or report to credit bureaus.	Yes	No

How does UFCW Union Local 880 Credit Union protect my personal information	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does UFCW Union Local 880 Credit Union collect my personal information	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> • open your account or apply for a loan • show your government-issued ID or give us income information • pay us by check <p>We also collect your personal information from other companies such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes-information about your creditworthiness • affiliates from using your information to market to you • sharing for nonaffiliates to market to you <p>State law and individual companies may give you additional rights to limit sharing.</p>

Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>UFCW Union Local 880 Credit Union does not have any affiliates.</i>
Nonaffiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>Nonaffiliates we share with can include insurance companies, government agencies, plastic card processors (credit/ATM/Debit), consumer reporting agencies, and check/share draft printers.</i>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • <i>Our joint marketing partners include CUNA Mutual Group's MEMBERCONNECT, credit card companies.</i>
